

## Appendix 2: Bachelor of Veterinary Nursing Programme Regulations

### ***Bachelor of Veterinary Nursing [BVN]***

To be read in conjunction with Unitec's Academic Statute, [Te Kawa Maiorooro | Educational Regulatory Framework](#) and associated Policies and Procedures.

These programme regulations apply to the Bachelor of Veterinary Nursing [BVN] programme, which leads to the award of Bachelor of Veterinary Nursing (level 7) qualification, (360 Credits) [3995-3].

These regulations come into effect from Semester 1, 2026.

#### **1. Ngā Ture Hei Whakaurunga | Admission Requirements**

To be eligible for admission to this programme, all applicants must meet three admission requirements:

- a. Requirements for either general admission, special admission, or discretionary admission
- b. Any additional Programme specific requirements
- c. English language requirements

##### **1.1 Whakaurunga Whānui | General Admission**

To be admitted to this programme all applicants must be at least 16 years of age on the date of the programme's commencement for the semester in which they wish to enrol (or provide a completed Early Release Exemption form), and meet the following requirements:

A minimum of 42 credits at NCEA Level 3 or higher on the National Qualifications Framework, with 14 credits at Level 3 or higher in each of two science-related subjects, with a further 14 credits at Level 3 or higher taken from no more than two additional domains on the National Qualifications Framework;

*And*

a minimum of 14 credits at Level 1 or higher in Mathematics or Pangarau on the New Zealand Qualifications and Credentials Framework;

*And*

a minimum of 8 credits at Level 2 or higher in English or Te Reo Māori; a minimum of 4 credits must be in Reading and a minimum of 4 credits must be in Writing;

*Or*

At least 3 'C' passes in the New Zealand University Bursaries Examinations in science or health science related field, where appropriate or equivalent;

*Or*

Successful completion of an appropriate qualification at Level 3 or above in a science or health science related field, where appropriate or equivalent;

*Or*

Equivalent.

##### **1.2 Whakaurunga Motuhake | Special Admission**

Applicants must have:

- a. attained the age of 20 years on or before the first day of the semester in which study for the programme is to commence; and
- b. provided sufficient evidence of aptitude or appropriate work or other life experience that would indicate a successful outcome in the qualification.

##### **1.3 Whakaurunga Kōwhiringa | Discretionary Admission**

In exceptional cases an applicant who does not meet the general admission requirements and who has not reached the age of 20 on or before the first day of the semester in which study for the Certificate is to commence may apply for discretionary admission. Applicants must have:

A minimum of 68 credits at NCEA Level 2 in their best four subjects;

*Or*

Have a maximum total of 12 in New Zealand Sixth Form Certificate in their best four subjects;

*Or*

Equivalent.

Note: Convictions of any offence and/or declaration of health conditions will not necessarily exclude applicants from enrolment. Any decision is made on a case-by-case basis at the discretion of the delegated authority._</p> <p>OR</p> <p>Successfully completed the New Zealand Certificate in Animal Technology (Level 5) or equivalent</p> <p>OR</p> <p>Successfully completed the New Zealand Diploma in Veterinary Nursing (Level 6) [Ref:2491] or equivalent.</p> <p>OR</p> <p>Successfully completed the New Zealand Diploma Veterinary Nursing (Level 6) [Ref:4389] or equivalent.</p> <p>Applicants whose veterinary nursing qualifications include credits at Level 4 may be admitted to the <i>Bachelor of Veterinary Nursing</i> following successful completion of additional courses from the New Zealand Certificate in Animal Technology or New Zealand Diploma in Veterinary Nursing [Ref:4389] schedule as required.</p> <p><b>1.5 Whakaurunga Reo Pākehā   English Language Admission Requirements</b></p> <p>Applicants must have achieved a minimum standard of English as demonstrated by a minimum of 8 credits at NCEA Level 2 in English (4 in Reading, 4 in Writing).</p> <p>International applicants and any Domestic applicant for whom English, Māori or NZ Sign is not their first language must also provide evidence that they have the necessary English language proficiency required for the Programme as demonstrated by the <a href="#">NZQA Rules</a> and on the Unitec <a href="#">English Language Requirements for International Students</a> Web-page.</p>

<b>6. Aromatawai Mahinga   Assessment Procedures</b>	<p><b>6.1 Ākoranga Aromatawai   Course Assessment</b></p> <p>Courses employ both formative and summative assessment activities. Formative assessments do not contribute to the final grade for a given course. All summative assessment elements are compulsory unless otherwise approved and noted in course descriptors.</p> <p>Students must attempt all compulsory assessment activities in order to pass and receive credit for any course. Students who do not attempt a compulsory item of assessment may be awarded a ‘Did</p>																																				

Not Complete'(DNC) for the whole course and may not earn any credits.

### **6.2 Aromatawai I Roto I Te Reo | Assessment in Te Reo**

All students have the right to submit any summative assessment task in Te reo Māori. The process for submission of summative assessment work in Te reo Māori is governed by the Unitec Assessment in Te Reo Māori procedure and detailed in course material.

### **6.3 Tāpaetanga Tōmuri | Submission and late submission of work**

- a. The due dates for all summative assessment work will be notified at the commencement of each course.
- b. Any assessment that is submitted late (and does not have a prior approved extension) will be penalised by a deduction of 10% per day of the participants assignment mark, up to five (5) days, inclusive of weekends.
- c. Applications for extensions must be made in writing to the relevant Academic Authority responsible for the assessment at least 24 hours before the due date. All applications must be accompanied by supporting evidence. An extension of up to five days may be awarded.
- d. Any extension will be carried out within a specified time period as agreed with the relevant academic authority and no further extensions will be granted.
- e. No assignment will be accepted five (5) days (inclusive of weekends) after the due date. If the assessment is not compulsory, the participants will receive a 'zero' grade for that assignment. If the assignment is compulsory, then the participants will receive a Did Not Complete (DNC) grade for the entire course.

### **6.4 Whakamātautau Anō | Resubmission or Reassessment**

A student may apply to undertake a resubmission/reassessment which scored a D grade within 5 days of receiving their marked assessment.

Award of a re-sit and/or re-submission is offered at the point of course results ratification at the end of each semester.

- a. Students may only resit or resubmit one assessment item for each course and the overall performance of the student and/or Assessment Concession will be taken into account when offering resits and/or resubmissions
- b. Students may only resit an assessment or examination to a maximum of two courses during any one academic year and/or at each level (fees may apply).
- c. All resubmissions/reassessments will be carried out within a specified time period as agreed with the relevant academic authority.
- d. In all cases for resubmission, the original marked assignment will accompany resubmitted assignments. If resubmitted work is not accompanied by the original marked assignment, the resubmitted work will not be marked, and the original grade will stand.
- e. The maximum grade for any resubmission/reassessment of an assessment is the lowest pass grade.
- f. Assignments that are handed in late are not eligible for resubmission or reassessment

### **6.5 Āhuatanga Aromatawai Motuhake | Assessment Concession**

A student may apply for Assessment Concession (AC) if:

- a. The student is unable to attend an examination, compulsory assessment or fixed time and place assessment activity due to illness, injury, bereavement, or other critical circumstances
- b. The student's preparation for, or performance in an examination or any summative assessment has been seriously impaired due to circumstances beyond their control

Applications for AC are made by a student within 5 working days of the affected assessment event.

Decisions to approve an AC and to apply any remedy are made according to the Assessment and Grading Procedures and Te Kawa maiorooro | Education Regulatory Framework.

### **6.6 Pāhi Rāhui | Restricted Pass**

A restricted pass may be awarded in a course which was narrowly failed and where there is ample evidence that marginal failure is compensated by good overall performance.

- a. A restricted pass is awarded at the discretion of the relevant academic authority and may not be applied for directly by a student.

	<p>b. The relevant academic authority may, at their discretion, use a restricted pass to:</p> <ul style="list-style-type: none"><li>• set conditions for future performance in other courses;</li><li>• prevent a student from using a restricted pass to meet the prerequisite requirements of another course.</li></ul> <p>c. A student may decline the award of a restricted pass by notifying the relevant academic authority in writing not later than 20 working days from notification of the results.</p> <p><b>6.7 Tuaruatanga   Repeating Courses</b> Students who are repeating a Level 1–8 course would normally be required to submit all assessment items. In some cases, with the prior approval of the relevant academic authority, students may not be required to repeat an equivalent assessment item that they had previously passed. This should be negotiated within the first two weeks of the commencement of the course and will specify any course grade that will be carried over.</p> <p>Students may enrol and repeat a course that they have failed only once. Permission to enrol for a third time is governed by Exclusion provisions below.</p> <p><b>6.8 Whakakorenga   Exclusions</b> No student will be allowed to enrol in any course more than twice unless there are exceptional circumstances approved by the relevant academic authority.</p> <p>a. Any Student who fails to achieve at least 50 per cent of the credits that he or she is enrolled in in any 12-month period may be excluded by the relevant Academic Authority from re-enrolling in any further courses. The decision whether students can re-enrol in further courses will be based on a student’s likelihood of succeeding in further study and will be made by the relevant Head of School.</p> <p>b.
